What is SSVF?

Supportive Services for Veteran Families (SSVF) assists extremely low and low-income eligible Veteran family and single Veteran households to obtain stable permanent housing. The Salvation Army was awarded a grant from the United States Department of Veteran Affairs to serve Veterans throughout the State of Kansas and Northwest Missouri. SSVF is a housing-first program designed to combat the disproportionate number of Veterans experiencing homelessness. Assistance is determined on a case by case basis, evidence of need, risk and vulnerability factors.

Eligibility

- Individual/head of household or spouse must be a United States Veteran with active military, naval, or air service and was discharged or released under conditions other than dishonorable or dismissed by reason of a general court-martial
- Fall below 50% of Area Median for their county
- Literally homeless or at significant risk of homelessness (as defined by the McKinney-Vento Act as amended by the Hearth Act)
- Must want to reside in Kansas or Northwest Missouri
- HUD-VASH participants must fall below 30% of Area Median Income for their location and must meet HUD's definition of chronically homeless.

Program Goals & Objectives

- Rapid Re-housing: Eligible literally homeless Veterans may be assisted with transition into appropriate, affordable permanent housing, and will exit the program into permanent housing obtained with or without other housing subsidies.
- Homeless Prevention: Veterans at the most significant risk of becoming homeless based on a risk factor screening assessment AND who lack other resources, MAY be assisted based on available funding, to remain housed or to be housed in alternative affordable housing units. Participants will be stably housed in permanent housing with or without other housing subsidies.

<u>I'm a Veteran/Veteran Household:</u> how can SSVF help?

- Call us and we will conduct a pre-screen by phone to determine your eligibility for the program
- If you are eligible we will set up a time and place to meet with you to determine how best to assist and to obtain needed documentation of eligibility
- If you are not eligible for our program, we can refer you to other resources

I'm eligible: what can you do for me/my family?

Services target homeless Veterans and prioritize those at most risk of homelessness. Specific services are determined on a case by case basis, and require documented evidence of eligibility, need and risk factors. Services MAY include:

- Case Management
- Housing counseling & housing location assistance
- Veteran Navigator for Vet-to-Vet support and to connect with Veteran, mainstream, and community resources
- Limited short-term rent/utility assistance, arrears, & deposits based on assessed need & resources
- Legal services
- Child care
- Mediation with landlords & utility providers
- Support in disability/benefit applications
- Depending on need, risk factors, and resources other services MAY be available

Eligibility & Service Limitations:

- VA regulations dictate eligibility requirements, limitations of assistance, time limits, financial assistance caps, and lifetime limits.
- VA regulations require the program to direct 60% of grant funds toward Rapid Re-housing of SSVF eligible homeless Veterans/Veteran households.
- * There is no guarantee that funds will be available for Homeless Prevention assistance at the time of request. Homeless Prevention assistance requires additional extensive assessment of risk factors and need. Only those with the most significant risks can be prioritized for assistance. This often causes delays, necessitates placement on a waiting list, or the person may be referred elsewhere for assistance.
- * VA regulations require that financial assistance if provided, may only be paid directly to third party entities on the Veteran's behalf. Cash assistance is not provided under any circumstances.
